# Article Laser-ablative synthesis of ultrapure magneto-plasmonic coresatellite nanocomposites for biomedical applications

Abstract: The combination of magnetic and plasmonic properties at the nanoscale promises the de-20 velopment of novel synergetic image-guided therapy strategies for the treatment of cancer and other 21 diseases, but the fabrication of non-contaminated magneto-plasmonic nanocomposites suitable for 22 biological applications is difficult within traditional chemical methods. Here, we describe a meth-23 odology based on laser ablation from Fe target in the presence of preliminarily ablated water-dis-24 persed Au nanoparticles (NPs) to synthesize ultrapure bare (ligand-free) core-satellite nanostruc-25 tures, consisting of large (several tens of nm) Fe-based core decorated by small (mean size 7.5 nm) 26 Au NPs. The presence of the Fe-based core conditions a relatively strong magnetic response of the 27 nanostructures (magnetization of >12.6 emu/g), while the Au NPs-based satellite shell provides a 28 broad extinction peak centered at 550 nm with a long tale in the near-infrared to overlap with the 29 region of relative tissue transparency (650-950 nm). We also discuss possible mechanisms responsi-30 ble for the formation of the magnetic-plasmonic nanocomposites. We finally demonstrate a protocol 31 to enhance colloidal stability of the core-satellites in biological environment by their coating with 32 different polymers (PEG-silane, PAAC, CMD, etc.). Exempt of toxic impurities and combining 33 strong magnetic and plasmonic responses, the formed core-satellite nanocomposites promise the 34 advancement of multifunctional modalities of image-guided therapies. 35

### 1. Introduction

Recent advances in the development of nanotechnologies have led to the emergence 40 of novel diagnostic and therapeutic modalities based on new nanomaterials[1–3]. Much 41 attention in this field is given to plasmonic nanoparticles (NPs), which are capable of 42 providing a variety of phenomena, including resonant optical extinction (absorption + 43 scattering) in the visible and near infrared (near-IR) range[4], strong local field enhance-44 ment[5], resistance to photobleaching and highly efficient photothermal conversion[6]. 45 Gold (Au) NPs present the most widely explored plasmonic nanomaterial[7] due to its 46

Au NPs were successfully used in therapeutic mo-48 dalities, including photo-induced hyperthermia[10] and in diagnostic modalities, includ-49 ing optical coherence tomography[11], photoacoustic tomography[12], and confocal re-50 flectance microscopy[13]. Magnetic NPs represent another appealing class of nanomateri-51 als for biomedical applications[14]. These NPs can be guided by external magnetic fields 52 both *in vitro* and *in vivo* to enable a series of therapeutic and diagnostic modalities, includ-53 ing magnetic resonance imaging[15], magnetic separation of cells and proteins[16], con-54 trollable drug delivery[17] and magnetic hyperthermia[18]. Among magnetic materials, 55 iron (Fe)-based NPs are considered to be the most promising due to their biocompatibility, 56 biodegradability and strong magnetic response[14]. 57

The combination of plasmonic and magnetic functionalities within a single nanofor-58 mulation looks especially interesting as it promises a synergetic enhancement of involved 59 therapeutic and diagnostic modalities. Fe-Au magneto-plasmonic nanostructures are typ-60 ically composed of a Fe-based core, covered by an Au shell (Fe@Au core-shells), which 61 makes possible both magnetic response and the generation of plasmonic extinction peak 62 in the visible and near-IR range[19]. Core-satellite structures present one of promising 63 variations of Fe@Au core-shell geometry, in which relatively large (>50 nm) Fe-based NPs 64 are decorated by a layer (layers) of small (<10 nm) Au NPs[20–25] (Fe@Au core-satellites). 65 These structures not only enable magneto-plasmonic response, but also offer a large sur-66 face for the conjugation with various functional biomolecules, as the surface area of satel-67 lite material (Au) is much larger compared to alternative structures of similar size (spher-68 ical nanoparticles, classical core-shells with completely covered core surface). However, 69 advantages provided by the core-satellite structures are usually compromised by a high 70 cost and complexity of synthesis procedures[20-22]. In fact, conventional chemical routes 71 imply stepwise processes, in which preliminarily prepared Au and Fe oxide NPs are first 72 functionalized by appropriate ligands, which renders possible a subsequent assembling 73 of the core-satellites [23-25]. Such techniques provide relatively good control of size, com-74 position, and structure of the Fe@Au core-satellites, but the use of ligands blocks surfaces 75 of Fe or Au (or both), which complicates their further conjugation with functional biomol-76 ecules and protective biopolymers. Moreover, biomedical applications of chemically syn-77 thesized NPs often have limitations due to the presence of toxic impurities originated from 78 precursors or incomplete reactions. Another synthesis pathway is based on X-ray radiol-79 ysis of HAuCl4 in colloidal solutions of Fe oxide NPs in the presence of a number of dif-80 ferent chemical substances [26], but this approach is also not free of residual contamina-81 tion problems and requires sophisticated and costly equipment. 82

Pulsed laser ablation is an alternative nanofabrication pathway capable of producing 83 nanostructures with various geometries, including the core-shell one. This approach is 84 based on a natural production of nanoclusters during the action of laser radiation on a 85 solid target[27]. When produced in a gaseous medium, the nanoclusters can be deposited 86 on a substrate to form a thin nanostructured film[28], while pulsed laser ablation in liquids 87 (PLAL) leads to the release of nanoclusters into the liquid medium to form a colloidal 88 solution[29]. A high efficiency and cleanness of this method made it highly suitable for a 89 plethora of applications in biomedicine[3,30,31]. As an example, we recently elaborated 90 the technique of femtosecond (fs) laser ablation in water and organic solvents, which re-91 sults in size controllable synthesis of NPs from a variety of materials, including Au[8], 92 Si[32], TiN[33], organic materials[34], and demonstrated their biosafety[35] and great po-93 tential for biomedical tasks. 94

PLAL has already been explored in the synthesis of Fe-Au NPs with diverse geometries. Barcikowski et al. ablated Au-Fe alloy target and found that structure of the produced core-shell NPs depends on NPs size and nature of the liquid media[36,37], while Amendola et al. demonstrated that nanosecond laser ablation from an Au-Fe alloy target or layers of alternating Au and Fe thin films in water and ethanol results in formation of 99 Fe-Au NPs of alloy or core-shell geometry[38,39]. It was shown that such NPs have re-100markable magnetic and plasmonic properties and are promising for magnetic resonance101imaging (MRI), SERS and computer tomography (CT) applications[38].102

Herein, we further extend the capabilities of laser-ablative methodology toward syn-103 thesis of core-satellite magneto-plasmonic structures. Our approach is based on fs laser 104 ablation from Fe target in aqueous colloidal solutions of small (< 10 nm) Au NPs, prelim-105 inarily prepared by PLAL. We show that the formed  $FexO_y@Au(x, y - variables)$  core-106 satellites exhibit good magnetic properties and significant optical extinction in the 107 window of biological tissue transparency. We then use different polymers to coat the core-108 shell nanocomposites and show that such a coating leads to their colloidal stabilization 109 even under storage in high ionic strength solutions. Such nanocomposites are promising 110 for multimodal magneto-optical biomedical applications. 111

#### 2. Materials and Methods

### 2.1. Synthesis of nanoparticles.

For the synthesis of FexOy@Au core-satellite nanocomposites we modified two-step 114method of fs PLAL, which was previously developed by our group for the preparation of 115 Gold-Silicon core-shell NPs[40,41]. A schematic diagram of the synthesis procedure is 116 shown in Figure 1. During the first step we synthesized Au NPs with mean size 7.5 nm 117 using radiation from the Yb:KGW laser (420 fs, 1025 nm, 10 kHz, 50 µJ) focused by a 75 118 mm lens on surface of a gold target (99.99 %, GoodFellow) immersed in 10 mL of 1 mM 119 aqueous NaCl solution, and placed 10 mm below the liquid surface. As previously 120 demonstrated[42,43], the addition of NaCl to water improves colloidal stability of laser-121 synthesized Au NPs and provides in situ control of the mean size of Au NPs by adjustment 122 of NaCl concentration. The Au target was continuously moved perpendicular to the laser 123 beam at a speed of 2 mm/s to avoid ablation from the same point. Duration of the synthesis 124 was 20 min. Mass concentrations of synthesized Au NPs was 0.1 g/L. During the second 125 step of the synthesis, a metallic Fe target (99.99 %, GoodFellow) was placed at the bottom 126 of the glass vessel filled with the colloidal solutions of Au NPs prepared in the first step 127 and laser ablation was performed with the same laser, but with slightly modified param-128 eters (repetition rate 5 kHz, pulse energy 100 µJ) for 15 minutes. 129



Figure 1. Schematic diagram of two-step PLAL synthesis of core-satellite Au-Fe NPs.

Non-reacted Au NPs were eliminated by magnetic separation step. For this a NdFeB 131 magnet was placed for 5 min next to the bottom of the test tube filled with the colloidal 132 solutions of NPs. The magnet attracted magnetic fraction of NPs to the bottom, while non-133 magnetic NPs remained dispersed in the solution. Then the solution from the upper part 134 of the test tube was discarded leaving about 20  $\mu$ L at the bottom and the test tube was 135 refilled with fresh 1 mM aqueous NaCl solution. The NPs remaining in the test tube were 136 re-dispersed by an ultrasonication step. The procedure was repeated 2 times to ensure 137

good separation of NPs. The obtained solutions were used for further experiments and 138 characterization. 139

### 2.2. Coating of nanoparticles.

Polyethylenimine (PEI) branched 25 kDa, polyallylamine (PAA) hydrochloride 17.5 141 kDa, carboxymethyl-dextran (CMD) sodium salt, polyacrylic acid (PAAC) sodium salt 5.1 142 kDa, polyethylene glycol-silane (PEG-silane) 5kDa, ammonium hydroxide 30% were pur-143 chased from Sigma. 144

NPs coating by CMD, PAAC, PAA and PEI polymers was performed by coincubation 145 procedure. 200  $\mu$ L of NPs suspension was mixed with 200  $\mu$ L of 10% w/v solution of a 146 polymer in distilled water. Then, the mixture was ultrasonicated, heated to 80 °C for 1 h, 147 cooled to room temperature and the NPs were washed 3 times with water by centrifuga-148 tion (20 000 g, 20 min). 149

NPs coating by PEG was performed by PEG-silane hydrolysis. For this 1 mg of NPs 150 were centrifuged at 20 000 g for 20 min and redispersed in dry ethanol. After that 10 µL 151 of 30% hydroxide ammonia and 50 µL of water were added to the suspension and NPs 152 were thoroughly ultrasonicated. Then 100  $\mu$ g of PEG-silane in 100  $\mu$ L of dry ethanol were 153 added dropwise, the tube was shaken and heated to 60 °C for 2 h. Then, NPs were washed 154 by centrifugation (20 000 g, 20 min) form unreacted chemicals 1 time with ethanol and 2 155 times with water. 156

#### 2.3. Characterization of nanoparticles.

Morphology, structure, size, and composition of the synthesized NPs were charac-158 terized by a high resolution transmission electron microscope (HR-TEM, JEM 3010, JEOL, 159 Japan) operating at 300 kV and by a scanning electron microscope (SEM, MAIA 3, Tescan, 160 Czech Republic) operating at 0.1 – 30 kV coupled with an energy dispersive spectroscopy 161 (EDS) detector (X-act, Oxford Instruments, UK). Samples for the electron microscopy were 162 prepared by dropping 1 µL of a NPs solution onto a carbon-coated copper grid (for HR-163 TEM imaging) or onto a cleaned silicon substrate (for SEM imaging) and subsequent dry-164 ing at ambient conditions. 165

 $\zeta$  – potential and hydrodynamic size were measured using a Zetasizer ZS instrument 166 (Malvern Instruments, UK) capable of measuring dynamic light scattering (DLS). Concentrations of NPs solutions were determined by measuring the ablation target weight before and after the ablation step and by dividing this mass difference by the ablation liquid 169 volume. 170

Optical extinction spectra were measured by a UV-VIS spectrophotometer (UV-171 2600, Shimadzu, Japan) using plastic cuvettes with 10 mm optical path length (for bare 172 NPs) or in 100 µL volume of 96-well plastic plate using Infinite M1000Pro (Tecan) micro-173 plate reader (for polymer coated NPs). 174

Magnetic properties of the NPs were measured using a superconducting quantum 175 interference device (SQUID; Quantum Design, MPMS XL) magnetometer. Magnetic 176 curves M(H), where M is the magnetization and H is the applied magnetic field, were 177 measured at T = 300 and 5 K. The zero-field cooling/field cooling (ZFC/FC) measurements 178 at H=100 Oe were also performed on the SQUID. In this purpose, the ZFC temperature 179 dependences of the magnetization were measured by cooling the sample from 325 to 5 K 180 and then applying a field of 100 Oe to record the magnetization, while the sample was 181 heated from 5 to 325 K. The field cooled (FC) measurements were made with a field of 100 182 Oe applied during the cooling process. 183

#### 2.4. Calculation of optical properties.

The extinction spectra of NPs were simulated using the electromagnetic Mie theory, 185 in which the numerical solutions are presented as infinite series of several combinations 186 of Bessel functions[44,45]. The numerical model was based on the implementation of 187 Yang's algorithm[46] for multilayered spheres[46,47] with the possibility of calculating 188

the optical response of an ensemble of independent particles with a normal size distribu-189 tion. Thus, the analytical solution for the light scattering by a multilayered sphere was 190 calculated by expressing the electromagnetic field inside each layer of the sphere as a lin-191 ear combination of the inward and outward travelling waves. Each layer was character-192 ized by a size parameter  $x_i = 2\pi n_m r_i / \lambda = k r_i$  and by a relative refractive index  $m_i = n_i / n_m$ ,  $i = n_i / n_m / n_m$ ,  $i = n_i / n_m / n_m$ 193 1, 2, ..., L. Here,  $\lambda$  is the incident wavelength in vacuum, r is the outer radius of the i<sup>th</sup> 194 layer, k is the propagation constant, and  $n_m$  and  $n_i$  are the refractive index of the medium 195 outside the particle and its  $i^{th}$  component, respectively, and L is the total number of layers. 196 L = 1 for spherical Au and Fe oxide NPs, while L = 2 for core-satellites. 197

#### 3. Results

Core-satellites were synthesized by two-step fs PLAL as described in Experimental 199 Section and schematically shown in Figure 1. The prepared colloids of nanocomposites 200 were almost black with a reddish-violet tint. To remove potentially unreacted Au NPs 201 from the colloid we separated magnetically active NPs by applying external magnetic 202 field. Before TEM and EDS imaging the colloidal solutions were additionally kept in a 203 dialysis tube (Serva Visking® 44120, pore diameter ca. 2.5 nm, buffer volume 3 L) for 20 204 hours to remove small amorphous iron oxide flakes. 205

The analysis of TEM images (Figure 2a) showed that most NPs had core-satellite ar-206 chitectures with higher contrast of satellites, which evidences the presence of Fe and Au 207 in the core and satellites, respectively. At the same time, HR-TEM studies clearly demon-208 strated polycrystalline structure of both the core and the satellites (Figure 2b). Figure 2c 209 (inset) presents the chemical elemental mapping obtained by EDS technique in HR-TEM 210 mode. The figure confirms that, the core was formed uniquely by iron-based compounds, 211 while Au was presented only in satellites. As follows from size histogram depicted in 212 Figure 2c, the size of Fe-based cores varied between 10 and several tens of nm with the 213 mean size 30 nm, while the mean size of Au satellites was 7.5 nm. It should be noted that 214 the core-shells nanostructures with Au core and Fe-based shell were also formed (data not 215 shown), when large (>10 nm) Au NPs were present in the colloid during the ablation of 216 Fe target. Similar tendency was earlier observed and explained for the synthesis of Fe ox-217 ide@Au core@shell nanostructures by laser ablation of Au-Fe alloy targets in water[48]. 218

Optical examination of the colloidal solutions (Figure 2d) revealed that the core-sat-219 ellites exhibited a strong extinction peak associated with the excitation of plasmon reso-220 nance in Au NPs[4]. The position of this peak (green line in Figure 2d) was red shifted 221 compared to the plasmonic feature of pure Au NPs centered at 521 nm (red line in Figure 222 2d). Indeed, the plasmonic peak of the core-satellites was centered at 550 nm and had a 223 broad shoulder extending over 800 nm, which largely overlaps with the optical window 224 of relative tissue transparency (650-950 nm). Such a shift and broadening of the plasmonic 225 feature is explained by the formation of core-satellites nanostructures, in which the core 226 and the satellites are formed by dielectric Fe oxide and Au, respectively. 227

We then carried out a series of calculations to simulate the observed plasmonic re-228 sponse. The numerical model was based on the implementation of Yang's algorithm for 229 multilayered spheres. In the case of simple one-component NPs (pure Au or Fe oxide NPs) 230 the solution corresponds to the classical Mie theory. In the case of core-satellites, we 231 adopted the effective-medium Maxwell-Garnett approximation describing satellites as a 232 layer (shell) with effective optical properties [49,50]. The effective shell consists of a matrix 233 medium (water) with Au NPs as inclusions. The resulted spectra along with the calcula-234 tion parameters are shown in Figure S1. The simulated extinction spectra are in a reason-235 able agreement with the experimental results. Good agreement was observed for the 236 curves calculated for bare Fe oxide NPs and Au NPs. For the core-satellites, even though 237 the applied approximation disregards coupling between resonant plasmonic modes of Au 238 satellites, the general trend is still rather well reproduced, particularly the peak and the 239 slow decay of the extinction coefficient with increase of wavelength. 240

We also investigated magnetic properties of the synthesized NPs. The results for pure 242 laser-synthesized Fe oxide NPs and for the core-satellite nanostructures are summarized 243 in Table 1. Hysteresis loops recorded at 5 K and 300 K are presented in Figure 3a. The 244 hysteresis loops at both temperatures were open and clearly showed ferromagnetic be-245 havior of the NPs. The coercive field at 5 K was slightly larger than at 300 K. The saturation 246 magnetization (Ms) of core-satellites (Ms=12.3 emu/g at 300 K) was significantly lower than 247 Ms of bulk magnetite (92 emu/g)[51] or bulk magnemite (76 emu/g)[52]. The Ms of pure 248 laser-ablated Fe oxide NPs was 44.7 emu/g at 300 K. The decrease of the saturation mag-249 netization values in comparison to bulk materials is typical for magnetic NPs[53] and it 250 depends on many factors, such as crystal structure, size, shape and surface properties[54]. 251 The differences in saturation magnetization can also be due to spin disorder at the surface 252 of Fe oxide NPs[55]. Moreover, the decrease of Ms of core-satellite NPs was also caused 253 by a relative decrease of magnetic material per gram of the nanocomposites due to pres-254 ence of Au satellites. 255

It is worth mentioning that magnetization hysteresis loops recorded at 5 K have a 258 clear negative shift from the origin along the field axis. This observation indicates a pres-259 ence of an exchange bias field (HEB), which originates from the interface exchange cou-260 pling between ferro (ferri)/antiferromagnetic[56]. The presence of exchange bias field can 261 also explain the high value of coercivity for the investigated NPs. Different phases of Fe 262 oxide in the nanocomposites, such as magnetite or maghemite, which are ferrimagnets, 263 and wustite (FeO), which is antiferromagnet, could be responsible for the exchange bias 264 fields[57]. ZFC/FC curves of the core-satellite nanostructures are presented in Figure 3b. 265 No well-defined maximum in the ZFC curve was found. This fact indicates that the NPs 266 had blocking temperatures above 325 K and exhibit ferromagnetic behavior at room tem-267 perature. 268

Structural and colloidal stability of the synthesized nanocomposites are very im-269 portant for the projected biomedical applications. To check the stability and find out 270 whether bonds between Fe oxide cores and Au satellites can withstand high ionic strength 271 conditions of physiologically relevant liquids, we incubated the laser-synthesized nano-272 composites in aqueous solutions of 1 M NaCl and in phosphate buffered saline (PBS) at 273 pH 7.4. Colloidal stability was poor in both liquids: hydrodynamic size of the nanocom-274 posites incubated at 37°C doubled after just 5 minutes (detailed kinetic of aggregation 275 over the course of 30 min is shown in Table S1). This result is not surprising since the 276 colloidal stabilization mechanism of bare laser-synthesized NPs is based on electrostatic 277 repulsion, while surface charges are effectively screened in high ionic strength liquids. 278 However, it is very important that the aggregation of the nanostructures was reversible 279 since it was possible to restore optical extinction spectra of the nanocomposites by simple 280 ultrasonication step. The reproducibility of the optical extinction spectra after re-disper-281 sion by ultrasonication means that the nanostructures preserved their structural stability 282 in high ionic strength solvents, although they were colloidally unstable. 283

To improve colloidal stability in high ionic strength liquids and to additionally en-284 sure structural stability of the nanocomposites we covered them using several different 285 biocompatible polymer coatings, namely: PEG-silane, PAAC, CMD, PEI and PAA. The 286 best colloidal stability was achieved using negatively charged polymer CMD, while other 287 coatings provided less colloidal stability, or the nanocomposites even aggregated during 288 the coverage procedure. The CMD coated nanocomposites did not change their hydrody-289 namic size after incubation for 24 hours in PBS (Figure 4a). The coverage by negatively 290 charged CMD polymer changed  $\zeta$  - potential of the NPs to -30 mV (Figure 4b) and slightly 291 increased their hydrodynamic size (Figure 4a), which additionally confirm success of the 292 coating procedure. 293

Our experiments showed that  $\zeta$  - potential was negative for bare laser-synthesized 294 Au NPs (-27 mV) and positive for both bare Fe oxide NPs (+30 mV) and core-satellite Au-295

Fe NPs (+28 mV). Therefore, one can suppose that electrostatic interaction can potentially 296 be a major formation mechanism of the nanocomposites. To test this possibility, we sepa-297 rately synthesized bare Au and Fe oxide NPs by a similar laser-ablative procedure (in this 298 case the Fe target was ablated in deionized water in the absence of Au colloids). Then the 299 Au and Fe-based NPs were mixed in a vial followed by vortexing for several minutes. 300 Finally, we compared the mixture of Au and Fe oxide NPs with nanocomposites obtained 301 by PLAL. We observed the presence of core-satellite Fe-Au nanostructures in the mixture 302 (Figure S2). However, there was a substantial difference in optical spectra of the samples 303 prepared by PLAL and by NPs mixing. In fact, as shown in Figure S3, the intensity of 304 plasmonic feature of core-satellites NPs normalized to Fe content was 5-folds higher for 305 laser-ablated NPs compared to that of NPs prepared by the mixing. 306

Therefore, the efficiency of the nanocomposite formation was significantly higher for the laser-ablative synthesis than for mixing of oppositely charged Au and Fe oxide NPs. 308 This fact suggests that there are other mechanisms leading to the formation of nanocomposites during ablation of Fe target in Au NPs colloids rather than simple electrostatic 310 interaction of oppositely charged NPs. 311

In our opinion, the formation of the core-satellites starts from an attraction of small 312 Au NPs to the forming Fe oxide NPs. The attraction between NPs is originated from sev-313 eral mechanisms including an electrostatic interaction between oppositely charged Au 314 and Fe oxide NPs, Van der Waals forces and hydrophobicity of both Au and Fe oxide NPs. 315 For the formation of stable core-satellites, Au NPs should arrive at the surface of Fe oxide 316 NPs, while the latter are relatively hot. As a result, these small Au NPs fill the potential 317 well at the interface with water, settle down at the surface as a result of sintering. Sintering 318 time is known to decrease with temperature [58]. In this way, core-satellites are formed 319 during a limited time (cooling time) after a laser pulse hits the target. This explanation is 320 supported by several observations. First, a simple mixing of Au and Fe oxide NPs is less 321 effective for the formation of core-satellite structures than the laser-ablative synthesis. Sec-322 ond, the satellites in the nanocomposites are predominantly formed by the smallest Au 323 NPs presented in initial gold colloid. Third, larger Fe oxide cores tend to form more core-324 satellite structures than smaller cores (Figure 2a, b). The second observation can be ration-325 alized by higher speed of NPs Brownian motion of smaller NPs (the speed depends on 326 the size as r<sup>-3</sup>). Therefore, small Au NPs move much faster than large ones and have higher 327 probability of reaching the surface of the Fe oxide NPs during the cooling time. The last 328 observation can be explained by longer cooling time of larger Fe oxide NPs, which gives 329 Au satellites more time to reach the Fe oxide cores. Also note that in our laser ablative 330 setup some of already formed nanostructures are re-irradiated by the laser beam. This re-331 irradiation can also contribute to the formation of core-satellites. 332

Thus, we managed to synthesize stable Au-Fe core-satellite nanocomposites, which 333 combine prominent magnetic response with the generation of plasmonic absorption peak 334 within optical transparency window. At the same time, unique laser-ablative synthesis 335 guarantees purity of the nanocomposites and free access to both Au and Fe surfaces for 336 further biofunctionalization. There is yet another advantage of the FexOy@Au core-satellite 337 nanocomposites, which potentially can solve the problem of residual accumulation of the 338 nanomaterials in an organism. Fe oxide cores can slowly degrade in physiological condi-339 tions and be excreted from an organism, while Au satellites are small enough to be elimi-340 nated through renal glomerular filtration mechanism[59]. Therefore, both components of 341 the core-satellites can be naturally removed from an organism, which promises a great 342 advancement in the field of nanomedicine, although this clearance pathway is still to be 343 verified in further research. Combination of these properties makes laser-synthesized 344 FexOy@Au nanocomposites highly suitable for both established and novel theranostic 345 magneto-plasmonic modalities for cancer therapy. 346

#### 5. Conclusions

In conclusion, we synthesized Fe<sub>x</sub>O<sub>y</sub>@Au core-satellite nanocomposites by using a purely 348 physical method of laser ablation in liquids, which insures a high purity of the obtained 349 nanomaterials and the absence of any residual contamination. We experimentally deter-350 mined optical, structural and magnetic properties of the nanocomposites and elaborated 351 a numerical model, which describes their optical properties. We showed that such 352 nanoformulations combine a strong magnetic response and a good optical extinction 353 within optical transparency window. Additionally, we demonstrated that the surface 354 coating of laser-synthesized nanocomposites with biopolymer CMD can significantly im-355 prove its colloidal stability in biologically relevant fluids that is very important for the 356 projected biomedical applications. From a broad perspective, our research provides a 357 novel extremely pure magneto-plasmonic platform for biomedical nanotheranostics. 358
